SCOPE OF ASSURANCE AND REPORTING CRITERIA

The assurance engagement was conducted to evaluate the accuracy and reliability of the sustainability performance information for the period from 2024 January to 2024 December included in the Report. Additionally, it assessed the extent to which the Report's content refers to the requirements of *GRI Standards 2021*.

ASSURANCE METHODOLOGY

The assurance comprised a combination of pre-assurance research, on-site interview with relevant employees (located at No. 2000, Fengyue Road, Changchun Automotive Industry Development Zone, Jilin Province, P.R. China); documentation and record review and validation where relevant.

The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

LIMITATIONS AND MITIGATION

Data drawn directly from independently audited financial accounts has not been checked back to source as part of this assurance process.

This assurance engagement was restricted to the group level of Zhuojun Holdings and did not include traceability of original data from all subordinate institutions.

This verification only conducted interviews with a part of staff and access to relevant materials, the external stakeholders were not involved.

STATEMENT OF INDEPENDENCE AND COMPETENCE

The SGS Group of companies is the world leader in inspection, testing and certification, operating in multiple countries and providing services. SGS affirm our independence from Zhuojun Holdings, being free from bias and conflicts of interest with the organisation, its subsidiaries and stakeholders.

On the basis of the methodology described and the assurance engagement performed, nothing has come to our attention that causes us to believe that the specified performance information for the period from 2024 January to 2024 December included in the scope of assurance is not fairly stated and has not been prepared, in all material respects, in accordance with the reporting criteria.

The assurance team concludes that the Report has referred to the requirements of *GRI Standards 2021*.
